- L Solara (Lifetime Limited Warranty) ASWF Warrants against peeling, cracking, adhesive failure, demetallization, delamination, fading, and no color change to purple for as long as the original customer owns the vehicle.
- L Carbon S, Carbon Ultra, Carbon Ultra IR (Lifetime Limited Warranty) ASWF Warrants against peeling, cracking, adhesive failure, delamination, and no color change to purple for as long as the original customer owns the vehicle.
- Excel<sup>T</sup>, Excel IRP<sup>C</sup> (Lifetime Limited Warranty) ASWF Warrants against peeling, cracking, adhesive failure, delamination, and no color change to purple for as long as the original customer owns the vehicle.
- Performer', Performer IRP' (Lifetime Limited Warranty) ASWF warrants against peeling, cracking, adhesive failure, demetallization, and delamination for as long as the original customer owns the vehicle.
- Limpulse (Lifetime Limited Warranty) ASWF warrants against peeling, cracking, adhesive failure, demetallization, and delamination for as long as the original customer owns the vehicle.
- Retro (Lifetime Limited Warranty) ASWF warrants against peeling, cracking, adhesive failure, and delamination for as long as the original customer owns the vehicle.
- L Dimension X' (Lifetime Limited Warranty) ASWF warrants against peeling, cracking, adhesive failure, and delamination for as long as the original customer owns the vehicle.
- L Dimension IRP (Lifetime Limited Warranty) ASWF Warrants against peeling, cracking, adhesive failure, delamination, and no color change to purple for as long as the original customer owns the vehicle.
- L Classic Pro\* (One (1) Year Limited Warranty) ASWF warrants against peeling, cracking, adhesive failure, and delamination for as long as the original customer owns the vehicle.

The obligation of ASWF under this warranty is limited to replacement of products not conforming to the warranty. The product is to be used in compliance with all applicable state or provincial laws. Installation of this product in a manner that violates state or provincial law is a misuse of the product and voids all warranties, expressed or implied, including but not limited to the warranty of merchantability. Do not roll down filmed windows for a period of 5 days until the film has properly adhered to the glass. Do not wash the film for 30 days after installation. Do not use abrasive cleaners or coarse cloths. Use mild soap and a clean, soft cloth or synthetic sponge.
